2. The Chairman of the Commission shall be Ex-Officio Chairman of the State Advisory Committee and the Secretary, JERC shall be Ex-Officio Secretary of the Committee.
3. The term of the Committee, shall be two years from the date of the constitution.
4. The State Advisory Committee shall advise the Commission on:-
- (i) Major questions of policy;
 - (ii) Matters relating to quality, continuity and extent of service provided by the licensees;
 - (iii) Compliance by licensees with the conditions and requirements of their licence;
 - (iv) Protection of consumer interest; and
 - (v) Electricity supply and overall standards of performance by utilities.
5. The Committee shall meet at least once in every three months.
