Chandigarh Renewable Energy Science & Technology Promotion Society (CREST) – Petitioner has filed the present petition for review of order dated 11.04.2014 passed by the Commission in petition no. 110/2014 filed by CREST for determination of preferential tariff under Net metering for rooftop solar photovoltaic power projects of CREST for sale of such power to Electricity Department UT -Chandigarh.

The review petition was received in the Commission on 23.05.2014. The petition was examined and found as per JERC (Conduct of Business) Regulations, 2009 and provisions of the Electricity Act, 2003.

The Commission admitted the petition on 26.05.2014. The Commission sent hearing notice to the parties for 24.06.2014. The Commission on 24.06.2014 heard the representatives of the parties. The representatives of the petitioner prayed for 21 days time for filing affidavit with documents in support of the petition.

The Commission vide order dated 24.06.2014 directed the petitioner to file affidavit with documents in support of their petition within 21 days and fixed the petition for hearing on 22.07.2014. The Commission on 16.07.2014 received an application from the petitioner with a prayer to grant 21 days more for submitting affidavit and documents as per order dated 24.06.2014.

Therefore, the Commission scheduled hearing on 21.08.2014. The petitioner has submitted affidavit along with some documents. The Commission held hearing today on 21.08.2014 at headquarters of the Commission.

The Commission heard the representatives of the petitioner at length and has gone through the main petition, order dated 11.04.2014 under review, present petition, additional petition and all the documents carefully and thoroughly. The Commission after hearing the representatives of the petitioner and going through the documents is of the opinion that the order dated 11.04.2014 requires review.

The Commission observes that if the order dated 11.04.2014 is reviewed the same will affect the public at large and before review of the order dated 11.04.2014 passed in main petition no. 110/2014, passing final order and disposal the present petition public hearing should be conducted and the public at large as well as consumers should be afforded opportunity to be heard.

The Commission, therefore, decides that public hearing be held at Chandigarh on 19.09.2014 and a notice for the same be issued accordingly.
