#### 1. Scope of Work for the Consultant (Tariff):-

1.1 To provide inputs for analysis of tariff petitions, and advise on the actionable issues arising in view of APTEL / Court orders.

1.2 To assist the Joint Commission by providing inputs for updation of Regulations

1.3 To provide inputs in adapting policies & regulations for promotion of competition, efficiency and economy in the electricity sector

1.4 To draft notices / Regulations

1.5 To prepare presentations on behalf of the Joint Commission

### 2. Scope of work for the Advisor (Tariff and Renewable Energy):-

- 1.1 To analyse various technical and economic aspects which are relevant to regulation of the renewable energy sector
- 1.2 To keep track of international and national trends in the Renewable Energy Sector

1.3 To collect relevant energy statistics

- 1.4 To assist the Commission in implementation of Regulations related to Renewable Energy tariff, RECs and other related matters
- 1.5 Other related issues e.g. Bench marking of cost of Renewable technologies
- Remuneration shall be governed by the provision of Regulation 8 of the JERC (Appointment of Consultants) Regulations, 2009 and shall be commensurate with the qualifications and experience and other terms and conditions thereof.

#### 4. Duration of contract:-

The advisor shall be engaged for a period of one year. The period of engagement may be extended / curtailed, based on the satisfactory performance of the applicant

#### 5. Payment Terms:-

The Advisor/Consultant shall be paid a lump sump monthly remuneration on completion of the month after deductions of tax at source as per the prevalent rules

\*In case of travel outside on an official tour duly approved by the Competent Authority, expenses for the journey undertaken by the Advisor shall be reimbursed as Air (Economy class), Train (II-AC), and other facilities shall be provided as per the entitlement of the officers at the level of a Director.

#### 6. Termination of contract:-

The assignment may be terminated before its term by either employer or employee by giving one month's notice or one month's salary in lieu thereof. In case of disciplinary action, the condition of notice period shall not apply to the JERC.

The appointment made under this assignment shall be on purely contract basis for a limited period only. Such appointment shall not vest any right to claim for regular appointment or continued contractual appointment in the JERC.

- 7. Only short-listed candidates shall be called for an interaction with the Selection Committee for the purpose of appointment.
