(d) Date and time of opening of quotations: **20-03-2017 03:30 PM**
- (e) Interested Companies / Firms may submit their quotations / tenders in sealed envelopes as per the details given in Annexure-'A' addressed to the Secretary, JERC, HSIIDC Office Complex, 2nd Floor, Vanijya Nikunj, Udyog Vihar-V, Gurgaon-122016. The quotations / tenders shall be opened on the same day at 3:30 pm in the conference room of the Commission. Interested firms may if they so desire, attend themselves or send their representative at the time of opening the quotations / tenders.
- (f) A demand draft of Rs. 5000/- (Rupees five thousand only) in favour of the Secretary, Joint Electricity Regulatory Commission. Gurgaon towards Earnest Money Deposit (EMD) should accompany the bid.
- (g) The Earnest Money Deposit shall be returned to the unsuccessful bidders after the finalization of the contract. The successful bidder shall have to furnish a performance security @ 10 % of the tendered amount in the form of DD/ Bank Guarantee and the EMD of the successful bidder shall be adjusted in the performance security.
- (h) Payment shall be made at the end of each quarter subject to satisfactory performance of the ACs.
- (i) The contract may be curtailed or extended with or without assigning any reason in case of unsatisfactory performance or reason beyond the control of the Commission, in which case pro-rata payment shall be made to the contractor.
