Terms and Conditions:-

- 1. Approximate running of 2500 KM in one month, from Dwarka, New Delhi (Residence of the officer) to office at Gurgaon
- 2. The Company / Firm must be registered with the State Transport Department of any state
- 3. The Company / Firm must have Service Tax Number
- 4. The Company / Firm must have up to date Road Tax, Pollution Certificate, Road permit and Insurance etc
- 5. All the costs relating to salary of driver, fuel, Insurance of Vehicle, wear and tear etc or any other accidental loss & theft of vehicle from anywhere will be borne by the Firm / Company
- 6. The Commission shall make monthly payment to the Firm / Company on production of bill by the Firm / Company in the following month.
- 7. Car mentioned above should not be more than 1 year old
- 8. In case of non-provision of the car in time on the place desired proportional amount of double rate would be deducted as per the contract rate

- 9. Toll tax, Parking fee, if any will be charged by the Company / Firm in the bill
- 10. Drivers must be in proper uniform while on duty & vehicle shall be kept neat and clean with seat covers, perfume, tissue papers, fire extinguisher and shall be kept in perfect running conditions
- 11. Extra car will be provided as and when required by the Commission.
- 12. This Office reserves the right to accept or reject any or all the bids without any reason whatsoever
- 13. Interested Companies / Firms may submit their quotation / tender as per the details in Annexure-'A' latest by 23/09/2015 till 3:00 PM in the name of Secretary, JERC. The quotation / tender will be opened on the same day at 3:30 PM. Firms may send their representative at the time of opening the quotation / tender
- 14. A Demand Draft of Rs. 10,000/- (Ten thousand only) in favour of Secretary, Joint Electricity Regulatory Commission, Gurgaon as earnest money, which will be returned to the unsuccessful bidders, after the finalization of the contract. The successful bidder will have to furnish the performance security of the prescribed amount and his EMD will be returned only after he furnishes the performance security.
