### **INFORMATION & SPECIAL CONDITIONS**

### 1. SCOPE OF WORK

Joint Electricity Regulatory Commission is having its headquarter in a rented building at HSIIDC Complex, 2nd Floor, Vanijya Nikunj, Udyog Vijar-V, Gurgaon. The office is on the 2nd floor comprising of 8820 sq ft area. Miscellaneous civil, sanitary, electrical repair/ maintenance/ Modification works are being carried out at regular intervals to maintain the ambience of the area. To carry out the said miscellaneous Interior, civil, electrical works etc. the Commission would like to select and empanel the eligible Agencies/contractors. The work shall be carried out as per the Commission's requirement as and when required & will be executed at the relevant CPWD rates.

The works have to be completed within the stipulated time frame without obstructing the functioning of the office. The works have to be carried out usually after office hours or on weekends i.e. Saturday, Sunday or on gazetted holidays. The work has to be completed to the entire satisfaction of the Officer-In-Charge of the work of the Commission.

- **2.** Tenders for the above-mentioned work are invited from specialized eligible reputed Contractors who meet the following minimum qualifications:
  - **A.** The tenderer should have their office in Delhi or NCR region. The tenderer shall submit copies of VAT, PAN & Service Tax certificates.
  - B. Should not have incurred any loss and must have an average annual financial Turnover not less than Rs. 20 Lacs during each of the financial years i.e. 14-15, 15-16 & 16-17. Information to be supported by copy of Income Tax Return, Audited / Certified by Charted Accountant balance Sheet and Profit & Loss account statements for the said financial years.
  - **C.** Should have a valid financial solvency of Rs. 5.00 Lacs (Solvency certificate issued by a scheduled bank within the last 6 months ending Empanelment bid ending date).
  - D. Have satisfactorily completed, one 'similar work' (in single contract) costing not less than the amount equal to Rs 08 Lakh or two similar works costing not less than an amount equal to Rs. 5.00 Lakh in Central Govt./Autonomous bodies/PSUs/Corporate/Private Companies during the period from 01/04/2015 to 31/03/2017.

Having experience categorically in the work relating to Execution/Renovation/Repair/Civil/Interior/InternalElectricalWorks/Plumbing/Sanitary/Woodwork/Minor Structural Steel Work etc. in Central Govt./Autonomous Bodies/PSUs/Corporate/Private Companies.

- E. Submit certificate of proof from the appropriate authority i.e. the Commission, of having satisfactorily completed the similar work as mentioned at D above.
- **3.** Submit Schedules/ Format- A to C duly filled-in with certified supporting documents and credentials along with other information/ data according to Check List enclosed to prove/ establish Pre-qualification for participation in the Tender.
- 4. No further discussion/ interface will be granted to bidders whose bids have been disqualified. JERC reserves the right to accept or reject in part or full any or all the offers without assigning any reason whatsoever.
- 5. Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders submitted by the Contractors who resort to canvassing will be liable to rejection.
- **6.** This Invitation to bid shall form a part of the contract document.

### **7.** Evaluation Criteria for Empanelment:

For the purpose of Empanelment applicants will be evaluated by scoring method on the basis of details furnished by them, as per Annexure – I, and the applicant's eligibility for Empanelment shall be determined.

Even though an applicant may satisfy the above requirement, he would be liable to be disqualified if he has:

- a. Made misleading or false representation or deliberately suppressed the information in the forms, statements and enclosures required in the prequalification document.
- b. Has a record of poor performance such as abandoning work, not properly completing the contract, or financial failures/ weaknesses etc.
- **8.** JERC reserves the right to accept or reject the Empanelment bid of any Tenderer without assigning any reasons and liability. JERC's decision shall be final and binding. No claim/ representation of any kind in this regard shall be entertained.

### Section-2

### 1.0 **GENERAL INSTRUCTIONS**

Joint Electricity Regulatory Commission (hereinafter called Commission) invites Bids in respect of Empanelment of Contractors for Renovation, Repair and Petty Civil and Internal Electrical Works including Plumbing, Sanitary, Masonry Woodwork, Minor Structural Steel work etc. at Head quarters at "HSIIDC Complex, 2<sup>nd</sup> Floor, Udyog Vihar-V, Gurgaon. All bids shall be prepared and submitted strictly in accordance with these instructions.

The Commission reserves the right to itself to accept any Bid or reject any or all Bids or cancel/withdraw Invitation to Bid without assigning any reason for such decisions. Such decisions by the Commission shall bear no liability whatsoever consequent upon such a decision.

### 2.0 INSPECTION OF SITE

2.1 The Bidders are at liberty to visit the site and examine the surroundings and satisfy themselves before submitting the tender. Tenderer shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charges contingent or any misunderstanding or otherwise shall be allowed.

### 3.0 **FORMAT AND SIGNING OF BID**

- 3.1 The bid must contain the name and place of business of the person or persons making the bid and must be signed and sealed by the Bidder with his usual signature. The names of all persons signing should also be typed or printed below the signature.
- 3.2 Bid by a partnership must be furnished with full names of all partners and be signed with the partnership name, followed by the signature(s) and designation(s) of the authorized partner(s) or other authorized representative(s).
- 3.3 Bids by Corporation/Company must be signed with the legal name of the Corporation/Company by the President, Managing Director or by the Company Secretary or other person or persons authorized to bid on behalf of such Corporation/Company in the matter.
- 3.4 Satisfactory evidence of authority of the person signing on behalf of the Bidder shall be furnished with the bid.
- 3.5 The Bidder's name stated on the proposal shall be the exact legal name of the firm.



### 4.0 **SEALING AND MARKING OF BIDS**

- 4.1 The envelope shall indicate the name and address of the Bidder to enable the envelope to be returned unopened in case it is declared "late" or "rejected". The envelope should be super scribed as "Empanelment of Contractors for Renovation, Repair and Petty Civil and Internal Electrical Works including Plumbing, Sanitary, Masonry Woodwork, Minor Structural Work etc." Due on 31/07/2017 at 15.00 P.M."
- 4.2 The envelope shall be addressed as below:

- 4.3 The outside of the envelope should also clearly indicate the name and address of the Bidder.
- 4.4 If the Bid is not sealed and marked as required under Clause 5.2 above, the Commission will assume no responsibility for misplacement and / or premature opening of the Bid.

### 5.0 OPENING OF THE BIDS BY THE COMMISSION

5.1 The Bids shall be opened by the Commission on any date after the last date fixed for Bid receipt as specified in the Invitation of Bids or in the case any extension has been given thereto, after the extended Bid submission date notified to all Bidders.

### 6.0 PRELIMINARY EXAMINATION

6.1 The Commission will examine the Bids to determine whether they are complete, whether Bidder fulfils the qualifying requirements and whether the Bids are generally in order.



- 6.2 Prior to detailed evaluation, the Commission will determine the substantial responsiveness of each Bid with reference to the Bidding documents. A substantial responsive Bid is one, which confirms to all the terms and conditions of the Bidding documents without material deviation. The Commission's determination of Bids responsiveness will be base on the contents of the Bid itself.
- 6.3 A bid determined as not substantially responsive will be rejected by the Commission and may not subsequently be made responsive by the Bidder by correction of the non-conformity.
- 6.4 The Commission may waive any minor informality or non-conformity or irregularity in a Bid, which does not constitute a material deviation. The decision of the Commission with regard to the deviation being material or not shall be final and binding.

### 7.0 EVALUATION OF BIDS

- 7.1 The Commission will evaluate and compare the Bids previously determined to be substantially responsive pursuant to Clause 6.0.
- 7.2 The enlistment of a contractor in JERC shall only entitle him to be considered for issue of tender papers subject to the conditions laid down in each individual Notice Inviting Tenders. It shall not confer any right on his either to be necessarily issue the tender papers or for award of work
- 7.3 The Bids submitted by the Bidders which do not meet the qualifying requirements as per Clause 2.0 Section I&SC will be treated as non-responsive and will be rejected .
- 7.4 Incomplete applications and applications not accompanied with necessary documents are liable to be rejected.
