ORDER

The Electricity Department of the Union Territory of Andaman & Nicobar (A&N) Islands has filed a Petition under section 86(1)(b) of the Electricity Act, 2003 seeking approval of the agreement for hiring of 1x750 KVA D.G. Set as standby power house at Secretariat Complex from M/s Mona Generator Services (P) Ltd.,

The Commission heard the Petitioner on 10.10.2017 and raised certain specific queries pertaining to the requirement of one 750 KVA D.G. Set as standby at the Secretariat Complex. The Petitioner requested the Commission to grant permission to respond to the queries and furnish additional information. The Commission granted liberty to the Petitioner to file the additional information by 25.10.2017.

The Petitioner vide its e-mail message dated 12.10.2017 has submitted that the Power Purchase Agreement with M/s Mona Generator Services (P) Ltd. for having a standby 750 KVA D.G. Set at Secretariat Complex is exclusively for the smooth functioning of the Secretariat of UT of A&N Islands. Further, the requirement of D.G. Set of adequate capacity is purely an administrative decision of the UT administration and, approval of Agreement by the Hon'ble Commission is / may not be required. The Petitioner has requested that it may be allowed to withdraw the Petition.


In view of the above, the Commission accepts the request of the Petitioner and grants it the liberty to withdraw the Petition. The Petition is therefore dismissed.
