The petitioner – Global Energy Pvt. Ltd. has filed the present petition before this Commission under section 14 of the Electricity Act, 2003 for grant of Intra- State Trading Licence in the State of Goa upto 80 MUs for 5 years.

The Commission found the petition in order as per JERC (Conduct of Business) Regulations, 2009 and admitted on 13.05.2013.

The petitioner as provided under Regulation 5.5 of JERC (Electricity Trading) Regulations, 2010 published the petition in daily "Gomantak Times" dated 12.05.2013 published from Panjim, Goa and the "Navhnd Times" dated 12.05.2013 published from Panjim, Goa and uploaded on its official website for inviting objections from all concerned/ stakeholders and general public. But no one filed any objection.

The Commission as provided under Regulation 5.8 of JERC (Electricity Trading) Regulations, 2010 also published the petition in daily "Gomantak Times" dated 12.07.2013 published from Panjim, Goa and "HERAL, GOA" dated 26.07.2013 published from Panjim, Goa and uploaded on its official website for inviting objections from all concerned/ stakeholders and general public and scheduled for public hearing on 19.08.2013 at Nalanda Hall, 5th Floor, EDC House, Atmaram Bonkar Road, Panaji- Goa.

The Commission on 16.07.2013 received objection petition from ED- Goa.

The Commission held public hearing on 19.08.2013 at Nalanda Hall, 5th Floor, EDC House, Atmaram Bonkar Road, Panaji- Goa. The Commission after hearing all concerned scheduled further hearing on 26.09.2013 at Nalanda Hall, 5th Floor, EDC House, Atmaram Bonkar Road, Panaji- Goa on request of the parties.

The Commission on 23.09.2013 received a petition in form of affidavit from the petitioner stating that at this point of time management of the petitioner has decided to withdraw the present petition and prayed to allow withdrawal of the petition.

The Commission considered the prayer of the petitioner and dismissed the petition as withdrawn.


