The petitioner ED-Chandigarh herein respondent filed petition no. 129/2014 for approval of detailed study on Manpower Requirement of Chandigarh Electricity Department conducted by M/s Deloitte Touche Tohmatsu India Pvt. Ltd. The Commission after hearing approved detailed study on Manpower Requirement of Chandigarh Electricity Department vide order dated 24.06.2014.

The U.T. Powermen Union Chandigarh through its General Secretary- objector herein petitioner has filed the present petition for review of the order dated 24.06.2014 in petition no. 129/2014 passed by the Commission.

The Commission received the review petition on 19.08.2014. The Commission examined the petition and found in line with the JERC (Conduct of Business) Regulations, 2009 and Electricity Act, 2003. The Commission admitted the petition on 19.08.2014 and numbered as petition no. 141/2014.

The Commission sent notice of hearing to the parties for 15.09.2014. The respondent filed reply on 15.09.2014. The Commission heard representatives of the parties on 15.09.2014 and on request of the petitioner adjourned the petition to 14.10.2014 for filing rejoinder by the petitioner to the reply of the respondent.

The Commission took up file on 08.10.2014 and scheduled hearing for today dated 28.10.2014. Rejoinder of the petitioner was received in the Commission on 09.10.2014.

The Commission heard the representatives of the parties for long time. The representatives of the parties during hearing pointed out that the respondent ED-Chandigarh has also filed a review petition for review of the same order dated 24.06.2014. Wherein the ED- Chandigarh has been directed to pay requisite fee as per the JERC (Conduct of Business) Regulations, 2009.

The present petition no. 141/2014 and the petition filed by ED- Chandigarh on 22.10.2014 are against same order dated 24.06.2014 passed by the Commission in petition no. 129/2014. Therefore, both the petition are required to be heard together and disposed off by common order. So, the present review petition be put up with the review petition filed by ED-Chandigarh after completion of legal formalities of the petition filed by ED- Chandigarh.
