The petitioner - M/s Perfect Filaments Ltd. has filed the present petition under Section 62 (6) of the Electricity Act, 2003 for recovery of excess amount of Rs. 4,82,213/- in flagrant disregard to Electricity Act, 2003 as well as Rules and Regulations framed time to time by the Commission.

The petition was received in the Commission on 10.09.2014. The Commission examined the petition and found it in line with the JERC (Conduct of Business) Regulations, 2009 and Electricity Act, 2003. The Commission admitted the petition on 15.09.2014.
