#### ORDER

Electricity Department Chandigarh – licensee filed a petition before the Commission for seeking approval of Application & Agreement Form (A&A) for LT/HT connections as per the provisions of the Electricity Act, 2003 and JERC (Electricity Supply Code) Regulations, 2010.

The Commission started hearings and sent notices to all its seven licensees to file their respective Application & Agreement Forms (A&A) for LT/HT connections for approval of the Commission as per the provisions of the Electricity Act, 2003 and JERC (Electricity Supply Code) Regulations, 2010.

Electricity Departments Goa, Chandigarh, Dadra and Nagar Haveli, Daman & Diu and Puducherry.

Electricity Departments Goa, Chandigarh, Dadra and Nagar Haveli, Daman & Diu and Puducherry licensees submitted their respective Application & Agreement Forms (A&A)

for LT/HT connections for approval of the Commission as per the provisions of the Electricity Act, 2003 and JERC (Electricity Supply Code) Regulations, 2010. The Commission vide order dated 30.01.2013 approved Application & Agreement Forms (A&A) for LT/HT connections of Electricity Departments Goa, Chandigarh, Dadra and Nagar Haveli, Daman & Diu and Puducherry licensees.

## **Electricity Department- Chandigarh**

Electricity Department- Chandigarh vide letter no. SEE/OP/C-1-2013/16/970 dated 1.03.2013 submitted that ED- Chandigarh filed Application & Agreement Form (A&A) for LT/HT connections for approval of the Commission as per the provisions of the Electricity Act, 2003 and JERC (Electricity Supply Code) Regulations, 2010 on 07.06.2011. ED- Chandigarh as per the directions of the Commission submitted revised Application & Agreement Form (A&A) for LT/HT connections for approval of the Commission on 30.01.2012. The Commission approved the Application & Agreement Form (A&A) for LT/HT connections filed on 07.06.2011 Annexed "B" vide order dated 30.01.2013. ED-Chandigarh prayed that the order dated 30.01.2013 may be recalled and the revised Application & Agreement Form (A&A) for LT/HT connections filed on 30.01.2012 be approved.

The Commission has gone through the request of ED- Chandigarh and Application & Agreement Forms (A&A) for LT/HT connections filed on 7.06.2011 and 30.01.2012 and order dated 30.01.2013 carefully and thoroughly. Since the Commission is fully competent to review its own orders under Regulation 74 of JERC (Conduct of Business) Regulations, 2009. Therefore, the Commission recalls/ reviews its order dated 30.01.2013 and approves the Application & Agreement Form (A&A) for LT/HT connections filed on 30.01.2012 by ED- Chandigarh as Annexed "B".

The Commission vide order dated 27.02.2013 allowed all the licensees to include AADHAAR in the list of ID proofs for release of Electricity connections.

# Electricity Department- Andaman & Nicobar respondent No. 2

The Commission heard representative of Electricity Department- Andaman & Nicobar, examined the Application & Agreement Form (A&A) for LT/HT connections of ED- Andaman & Nicobar carefully and thoroughly and found the same is in line with the EA, 2003 and JERC (Electricity Supply Code) Regulations, 2010. Therefore, the Commission approves the Application & Agreement Form (A&A) of ED- Andaman & Nicobar for LT/HT connections Annexed "F".
