The petitioner Suryachakra Power Corporation Ltd. has filed the present Petition for adjudication of disputes between M/s Suryachakra Power Corporation – a power generating company- and Electricity Department Andaman & Nicobar Islands - a distribution Licensee- under Regulation 65 of JERC (Conduct of Business) Regulations, 2009 and Section 86 (1) (f) of the Electricity Act, 2003.

The Commission heard the representatives of the parties at length and has gone through the record carefully and thoroughly. The Commission observed that the present petition is admitted on 30.01.2013 and numbered petition no. 97/2013.

The Commission in petition no. 89/2012 filed by M/s Suryachakra Power Corporation for fixation of completed / actual capital cost of project and Tariff of the project of the petitioner- a Power Generating Company under Regulations 3(2)(a), 3(4), 12 and 36 of the Joint Electricity Regulatory Commission for the State of Goa and Union Territories (Terms and Conditions for determination of Tariff) Regulations, 2009 read with section 62(1) (a) and 63 of the Electricity Act, 2003 passed an order dated 18.02.2013. The Commission in the order dated 18.02.2013 passed in petition 89/2012 has directed the parties to submit compliance report of the order dated 18.02.2013 by 11.03.2013. The Commission further observed that some contents of both the petitions no. 89/2012 and 97/2013 overlap, therefore, till disposal of the petition no. 89/2012 the present petition no. 97/2013 is adjourned sine die.
