Petitioner submitted combined ARR and Tariff Petition for FY 2011-12 and FY 2012-13.

Consultant of Petitioner made representation of salient features of the combined Petition.

During hearings following discrepancies and gaps are pointed out by the Commission:-

- 1. Complete data of Power Purchased, Energy Sold Revenue category wise (format 4 & 28) for the FY 2011-12 on actual basis be filed.
- T&D losses projected for FY 2011-12 & 12-13 as 12.5%. The same requires to be reduced at least by 0.5% in the year 2012-13. The Road Map for further reduction of T&D losses may be submitted.
- Employees cost is high. What bench mark is being followed?
 Action proposed to reduce the employee's cost to a reasonable level.
- Arrears due from Govt. Deptt. If any, ending march, 2011 & 2012 and action proposed for its recovery during FY 2012-13 to be submitted.
- 5. The Tariff schedule is very long and complicated for an average consumer which requires simplification so as to be understood easily by the consumers in general. The number of categories of consumer for tariff schedule should be reasonable.
- 6. The Terms and conditions of the Proposed Tariff schedule should be as per JERC Electricity supply code® 2010, and Electricity distribution code, 2010 of JERC.
- 7. There is Proposal of Power Purchase from one IPP amounting to Rs. 108 cr i.e at the rate of Rs. 10.03 per unit where as the sale under UI and Power exchange etc. actuals for 2011-12 and proposed for 2012-13 are at a much lower rate. The justification for Power Procurement from the said IPP, at such a higher rate to be provided. The date, time, frequency and price at which the power has been procured from the said IPP during year 2011-12 to be provided.

The details of power purchase outside permissible frequency band as per CERC order be given along with quantum and rate at which same was purchased.

- The demand charges amongst the HT category consumers varies from Rs. 150 per KVA to Rs. 700 per KVA. Though energy charges per unit are similar. The justification for such a high variation is required.
- The justification of giving status of seasonal industry to Mining in the tariff schedule needs justification.
- Justification of not recovering arrears of cost of supply from Government Departments and Utility.
- 11. Justification of non tariff income is required.

Petitioner is directed to furnish above information and remove discrepancies and gaps.

Petitioner requested for 10 days time for furnishing the above information.

Request acceded.

The Petitioner is directed to furnish the requisite information by 24.04.2012.
