Request acceded. The Commission directed Electricity Department of DNH to file the report in respect of AT & C loss reduction programme and road map for ensuing year and next three years by 31.07.2012.

Letters be sent to Chief Secretaries/Administrators of UTs of Andaman & Nicobar, Daman and Diu and Lakshadweep directing them to take appropriate action in their respective Union Territories for non appearance before the Commission and non submission of detailed report and road map in respect of AT&C loss reduction programme for ensuing year and next three years.

Notices be also sent to Power Secretaries/ Administrators of UTs of Andaman & Nicobar, Daman and Diu and Lakshadweep for submission of detailed report by 31.07.2012

Electricity departments of Goa, Chandigarh and Puducherry are directed to file further status report by 31.10.2012.
