The respondent has not complied directions of the Commission. The respondent has also not complied Regulation 8.1 of JERC (Electricity Supply Code), Regulations, 2010. The Commission directed the respondent to make sincere efforts for compliance of Consumers metering, reading and billing category wise as per Regulation 8.1 of JERC (Electricity Supply Code), Regulations, 2010 and submit latest detailed report, action plan and road map on status of Consumers metering, reading and billing category wise on or before 15.7.2013 positively.
