INTERIM ORDER

1. Heard the Respondent at length.
2. The Respondent submitted the details of current projects and ongoing projects to comply the Renewable Purchase Obligation. The details/action taken are as follows:
 - Letter sent to MNRE/MoP requesting technical guidance for preparation of tender sent on 17-04-2025 for the project of 20.95 MW and the capital cost of Rs.256 Crores.
 - Letter to MNRE/MoP requesting technical guidance for preparation of tender on 22-04-2025 for the 30MW Roof Top Solar projects on residential Buildings and the capital cost of Rs.176 crores. CFA proposals for release of Rs. 99 Cr. has been submitted to the MNRE on 30.04.2025.
 - The tender documents for a project of 3.45 MW Rooftop Project on 917 Govt. Buildings and the project cost of Rs. 45.61 Cr. Plus GST by NVVN has been

approved by the Hon'ble Lieutenant Governor. NVVN has been communicated to initiate the tendering process.

- A meeting has been held on 15.04.2025 under the Chairmanship of Secretary (Power) A&N Islands, with NLCIL officials to establish 20 MW project in Dollygunj.
3. The Respondent has further stated that proposal for procurement of RECs towards RPO compliance for FY 2024-25 has already been proposed for approval of the Competent Authority at Andaman & Nicobar Administration. They further stated that the RPO compliance as directed vide JERC order dated 21.01.2025 in Suo-Moto Petition No. 61/2012 shall be complied with latest by 15th July 2025.
 4. The Respondent is directed to submit a report with regards to procurement of RECs to comply with the RPO targets of FY 2024-25 by 15th July 2025. In case of non compliance of the direction, the appropriate action under Section 142 of the Electricity Act, 2003 shall be initiated.
 5. Ordered accordingly.
