JERC reserves the right to not to fill up the above positions or to cancel/amend the entire/part of this advertisement/ recruitment process/condition of recruitment and the candidature is liable to be rejected at any stage of recruitment process at any time, without assigning any reasons, whatsoever.
- c. The age of the candidate shall not exceed 56 years on the last date of receipt of application. The age limit of the candidates will be calculated on the basis of the Matriculation Certificate/Date of Birth certificate issued by a recognized Authority/Board/Council.
