1. Both parties have been heard at length.
2. Fresh Vakalatnama on behalf of Respondent No. 2, CPDL is filed. Same is taken on record.
3. The Respondent No. 1, EWEDC submitted that the proposal for the past dues to be paid to NIELET and the agreement to be executed is still pending with the Competent Authority for approval, therefore seeks further time to file the Compliance Report.
4. The Respondent No. 2, CPDL submitted that upon receipt of requisite information, the amount shall be refunded to the consumers in next upcoming bills. The amount so payable shall be adjusted from the past arrear dues recoverable as per Clause 10 of the Share Purchase Agreement. The Respondent No.1, EWEDC submitted that they have no objection to such adjustment.

5. Upon hearing both the parties, the Commission directs the Respondent No. 1, EWEDC to file the Compliance Affidavit within one week.
6. On failure to file the Compliance Affidavit, the Commission directs the Secretary (Engineering) to appear in person and explain the reasons for such delays.
7. The next date of hearing is fixed on 11.11.2025 at 11:30 am.
