The Secretary (Power) was also requested to intervene and issue necessary directions to secure compliance.
- 9. Thereafter, by a further email dated 30.10.2025, Respondent No. 21 recorded that Chandigarh Electricity Department had earlier confirmed that the true up petitions would be filed by 30.09.2025, noted that the same were still pending, and once again requested Chandigarh Electricity Department to update the status in view of the affidavit required to be filed before this Hon'ble Tribunal regarding submission of

- 11. At the outset, Respondent No. 21 submits that it has been consistently pursuing the matter of filing of pending true up petitions by the Lakshadweep Electricity Department, even prior to the passing of the Order dated 26.09.2025 by this Hon'ble Tribunal.
- 12. In this regard, it is submitted that on 18.09.2025 and 19.09.2025, Respondent No. 21, through its Regulatory Affairs (Engineering) wing, addressed emails to the Executive Engineer, Lakshadweep Electricity Department, seeking the status of filing of the pending true up petitions and calling upon the Department to submit the status by the same day on priority. The Secretary (Power) was also requested to intervene in the matter and issue necessary directions for immediate compliance. [True copies of the Email dated 18.09.2025 and the follow up Email dated 19.09.2025, along with the chain of correspondence, are collectively annexed herewith and marked as **Annexure 6** (colly)].

It is further submitted that the Lakshadweep Electricity Department responded by letter dated 19.09.2025, stating that the Proforma Accounts for FY 2020-21 and FY 2021-22 had been submitted to the Senior Audit Officer, Kochi, for auditing, that the Proforma Accounts for FY 2022-23 and FY 2023-24 were under preparation by the consultant, and that the true up petitions would be filed upon completion of the audit of the accounts. Thereafter, and as already placed on record by Respondent No. 21 in the earlier Additional Affidavit dated 17.10.2025, Respondent No. 21, in compliance with the Order dated 26.09.2025 passed by this Hon'ble Tribunal, issued a letter dated 16.10.2025 to the Secretary (Power), UT Administration, Lakshadweep, drawing attention to the pendency of true up petitions for Lakshadweep from FY 2020-21 to FY 2023-24 and to the directions contained in this Hon'ble Tribunal's Order in O.P. No. 1 of 2025.
- 15. By the said letter dated 16.10.2025, Respondent No. 21 recorded that this Hon'ble Tribunal has directed that "JERC to take necessary action to expedite submission of Petitions for True up and issuance of True up orders for Lakshadweep", enclosed a copy of the Order dated 26.09.2025, and requested the Secretary (Power) to direct the concerned officials of Lakshadweep Electricity Department to take immediate action and file the pending true up petitions at the earliest, treating the matter as most urgent. [True copy of the Letter dated 16.10.2025 issued by Respondent No. 21 to Lakshadweep Electricity Department is annexed herewith and marked as Annexure 8].
- 16. Subsequent to the Order dated 30.10.2025 passed by this Hon'ble Tribunal, and in furtherance of the above communications, Respondent No. 21 again wrote to the Secretary (Power), UT Administration, Lakshadweep by Email dated 31.10.2025, reiterating the reference to pending true up petitions for FY 2020-21 to FY 2023-24, and once again drawing attention to the directions issued by this Hon'ble Tribunal in O.P. No. 1 of 2025. The said email requested that the concerned official be directed to take immediate action and file the pending true up petitions at the earliest, and requested that the matter be treated as most urgent.
